Unashamedly Ethical Violations:

On 05 August 2015; I submitted a written Request for Information to Unashamedly Ethical Administrator, Executive Committee and International Board of Advisors; and Family Policy Institute; titled: *Are Unashamedly Ethical conflict problem solving ethics founded on Ecology of Peace or Masonic War is Peace values.*

As of 05 August 2015; respondent: Jaap Le Roux has refused to answer my – Are Unashamedly Ethical conflict problem solving ethics founded on Ecology of Peace or Masonic War is Peace values -- requests for information.

As of 18 March 2013; respondent Errol Naidoo has refused to answer my repeated – Are Unashamedly Ethical conflict problem solving ethics founded on Ecology of Peace or Masonic War is Peace values -- requests for information.

As of 05 August 2015 respondents: Graham Power; Ras Myburgh; Edward Beeka; Amanda Buys; Patrick Kuwana; Chris Lodewyk; Mgayi Bongani; Gert Roberts; Zevenster Hardus; Roy Chen; Dan Daniels; Datuk Edward Ong; Don Simmonds;; Dr Geoff Tunicliffe; Phil Warbrick; have done nothing – to my knowledge – to demand that Jaap Le Roux abide by ethical communication principles of honesty; to honestly and simply answer the -- Are Unashamedly Ethical conflict problem solving ethics founded on Ecology of Peace or Masonic War is Peace values -- request for information questions submitted to Unashamedly Ethical.

Unashamedly Ethical Code of Ethics Violations:

1. To be entirely truthful in all you say.

Refusing to answer questions; is a form of withholding the truth; and consequently not truthful.

2. To do nothing out of selfish ambition or conceit, but to look out for the interests of others.

Withholding honesty; to falsely or fraudulently manipulate public perception is generally a result of selfish ambition or conceit.

3. To refuse to elicit, accept or pay any bribes and to encourage others to do the same.

Withholding honesty about the difference between real root cause problem solving of society's socio-religious and psycho-political resource war conflicts; is a form of ideological false reality bribing.

4. To be diligent without being harsh, and striving to be just and fair.

Withholding information that would contribute to justice and fairness; is not being just and fair.

5. To be a peacemaker.

Withholding information about how to be a real peacemaker to address the root causes of society's socio-religious and psycho-political resource war conflicts; is being a false peacemaker. False peacemakers only make social conflict worse; by deliberately withholding from people the information to enable society to address the root causes of social conflict.

6. To collaborate with your peers to impact our community and nation.

Withholding information about how to sincerely, honestly and transparently address the root causes of a community or nations social conflict; is negatively impacting your community by contributing to violence, ignorance and social conflict.
